Fair Play Agreement, TOTS Agreement and Release Form.

The Beaverlodge and Area Minor Soccer Association strives to create a safe and fun environment for all participants. Our primary objective is to get children active and having fun in the context of the game of soccer. We hope to teach fair play, sportsmanship, and teamwork, as well as basic soccer skills. Any verbal or physical actions that are, in the eyes of the Coaches, Referees, or Soccer Members, that violate these goals can result in the offending spectator or player being asked to leave the field. In some cases, there may be grounds for an additional game suspension. Refusal to accept this request or repeated non-compliant behavior will lead to the removal of your child from the league. Parents and other spectators should not interfere during game play. All cheering must be positive in nature. Coaches, Referees and Soccer Members are also subject to the Fair Play Agreement.

All kids must wear shin pads under their soccer socks and have soccer cleats or lace up runners. There are **NO EXCEPTIONS**. Each child is covered under the Northwest Peace Soccer Association Insurance. If your child was to injure themselves during one of the games played on scheduled days, they would be covered providing they are wearing the proper attire. There are no exceptions. Due to safety concerns, if proper attire is not worn, your child can not play.

Please note that in the eyes of the Beaverlodge and Area Minor Soccer Association it is not reasonable to leave players at the U5 age level alone at their playing field. This can potentially place our coaches in uncomfortable, difficult, and even dangerous situations. In registering your child in the U5 division, we ask that you confirm that you or a suitable guardian or caregiver will be present at the field at all times while your child is on the field. We appreciate your understanding in this matter.

By signing the bottom, I agree with the above statements, and accept that if I, or another spectator related or associated with the child named on this form, is in violation of the fair play rules of the league, it may be cause to remove the child from the league for the remainder of the season. I understand that **no refund** will be given. I accept that decisions of the Beaverlodge and Area Minor Soccer Association on this matter are final and binding.
